Rules and Regulations

1. Vendors must provide and prepare their tented area to **meet health requirements of Fulton County (www.fultoncountygga.gov/county/health)**. Set up will be on **pavement**. You must provide roofing tarp to cover the pavement to prevent staining and damage.
2. After unloading, **Vendor’s vehicles** will not be permitted to remain in the exhibition space or surrounding area during the Festival, nor may they enter the Festival Grounds until at least one half hour after the festival closes.
3. Each Vendor shall be responsible for obtaining any **required licenses, permits or approvals** under state laws applicable to his/her activity at Festival 2011 and for paying any taxes, sales taxes, fees or other charges that may become due to any governmental authority in connection with the Vendor’s activity at the Festival. We must have required permits and insurance info **3 weeks** (July 22nd) prior to the Festival.
4. The Festival is a **rain or shine event** and will be held on August 13th, 2011. No-shows will not be invited to future Festivals.
5. The Festival reserves the **right to cancel** a Vendor’s contract and require Vendor to leave the Festival at any time the Vendor is in violation of the Rules and Regulations herein.
6. Neither Heritage Sandy Springs nor its agents or representatives will be responsible for any injury or damage or loss that may occur to the Vendor, the Vendor’s agents or representatives, or the Vendor’s property from any cause whatsoever. Vendor should obtain, at their own expense, **insurance** against any loss, damage or injury they may require.
7. You may only sell food and beverages that are listed and approved on your menu listed on this application.
